Commanders Message:

Greetings Coon Valley American Legion Family

We had a very successful Vernon County Banquet at our post on March 03, and if you weren't there, you missed a good time, and an excellent meal. I would like to thank Roger Mathison for heading this up. Roger and Ron Miller prepared the food, and the meal was served by the Auxiliary. There were 95 people in attendance. Thank you to everyone who participated in this event. Other Posts in the county complain when they host the banquet that they lose money or make very little. Roger reports we cleared close to \$500.00 dollars. Go figure.

Everyone, please note that our March meeting will be on Thursday, March 15, 2018, due to Lent. We had a very poor attendance at our Feb. meeting because of the same situation, so mark your calendars. You don't want to miss this meal. The Auxiliary will be fixing a few turkeys and all the trimmings. Our meeting will start early, at 7:00 p.m., followed by the meal at 7:30, followed by the County meeting. It's always a good time.

You may recall that in December our Post received a \$1500.00 check from Mr & Mrs. James Onshus to be directed to wounded warriors in Vernon County. Roger Mathison and I had a conversation with Vernon County Veterans Service Officer Jim Young in January, & he stated he often gets emergency situations for veterans that he doesn't always have the funds to cover from his funds. On February 27, our Post received a plea for help from the Veterans Service Office. Jim had an Iraq veteran, two tours of duty, 100% disabled, with traumatic brain injury. The veterans' wood stove was no longer serviceable, and they were using two electric space heaters for heat. The veteran has a wife and a 14 month old child. The contractor recommended a new pellet stove would be the way to go for a cost of \$2000.00. Your officers texted each other and agreed Roger would hand deliver the check to Viroqua for \$1500.00 the same day. The County made up the difference and the veteran has heat and is very, very grateful.

Were you in the Navy or have you ever been interested in Navy ships? On Thursday, August 23rd, there will be a mini bus trip to Dubuque, IA to tour the USS LST 325. This LST (Landing Ship, Tank) is an amphibious vessel deigned to land battle-ready tanks, troops and supplies. This will be the first time ever that this ship will have sailed up the Mississippi River this far north.

Admission for the tour is \$10.00, mini bus ride is \$7.00. WWII Veterans get to tour the ship for free.

Topics of instruction include criminal law, constitutional law, patrol procedures, criminal investigation procedures, traffic crash investigation, evidence gathering techniques, arrest techniques, taking fingerprints, testifying in court, public speaking, leadership skills, report writing, interviewing techniques, crisis intervention, use of control and firearms training.
